MEMORANDUM FOR United States Army, Promotion Work Centers

SUBJECT: HQDA Promotion Point Cutoff Scores (COS) for 01 September 2026 and Semi-Centralized Reminders and General Information for the United States Army Reserve, Active Guard Reserve

1. **Reference(s):**

- a. Army Regulation (AR) 600-8-19, Enlisted Promotions and Demotions, dated 06 March 2026, effective 06 April 2026, Click [HERE](#).
- b. Integrated Personnel and Pay System - Army (IPPS-A), User Manual – Version 19.1, dated: 02 July 2026, Chapter 18, Click [HERE](#).

2. **Work Analysis and Integration.**

- a. **Purpose:** To reinforce current procedures concerning the above subject.
- b. **Function:** Enlisted Promotions and Demotions.
- c. **Task:** Process monthly Headquarters, Department of the Army (HQDA) promotion point COS and enlisted promotion information.

3. **Board Requirements:**

- a. Eligible Soldiers who meet the following criteria may appear before a promotion board between 10 July 2026 through 26 July 2026 as follows:
- b. To Staff Sergeant (SSG) must graduate from the Basic Leader Course (BLC) prior to board appearance.
- c. To SSG **primary** zone: Sergeant (SGT) with minimum 70 months time in service (TIS) and 16 months time in grade (TIG).
- d. To SSG **secondary** zone: SGT with minimum 46 months TIS and 6 months TIG.

e. To SGT there is no Professional Military Education (PME) requirement for board appearance.

f. To SGT **primary** zone: Corporal (CPL) / Specialist (SPC) with minimum 34 months TIS and 10 months TIG.

g. To SGT **secondary** zone: CPL/SPC with minimum 16 months TIS and 4 months TIG.

h. Soldiers must meet all eligibility criteria in accordance with (IAW) [Reference 1A](#), Table 3-1.

4. Pin-On Requirements:

a. To SSG must graduate BLC before they are eligible for promotion pin-on.

b. To SSG **primary** zone: SGT with minimum 72 months TIS and 18 months TIG.

c. To SSG **secondary** zone: SGT with minimum 48 months TIS and 8 months TIG.

d. To SSG **MLI**: SGT with minimum 84 months TIS and 24 months TIG.

e. To SGT there is no PME required for promotion pin-on to SGT.

f. To SGT **primary** zone: CPL/SPC with minimum 36 months TIS and 12 months TIG.

g. To SGT **secondary** zone: CPL/SPC with minimum 18 months TIS and 6 months TIG.

h. Soldiers must meet all eligibility criteria IAW [Reference 1A](#), Paragraph 5-5.

i. Soldiers (*including Soldiers currently in the rank of SGT under the provisions of Mandatory List Integration (MLI)*) who are otherwise eligible, hold recommended list status and have all supporting data entered into the systems of record as of 26 July 2026 who meet or exceed the COS as they appear beginning on page 7, may be promoted effective 01 September 2026. These Soldiers will appear on the corresponding HQDA By-Name List (BNL) for SGT / SSG published this same date.

REMINDERS / GENERAL INFORMATION:

1. **AR 600-8-19**, Enlisted Promotions and Demotions, dated 06 March 2026, effective 06 April 2026. Click [HERE](#) to access via the US Army Publishing Directorate.
2. **Promotion Cycle** - IAW [Reference 1A](#), paragraph 3-3, f, promotion points take effect on the first calendar day of the following month. For example, a Soldier approved for promotion list integration on 26 July 2026 will compete against the 1 September 2026 COS. Any data change that results in an updated promotion-point total, if entered after the 26th calendar day of the month, will affect promotion scores for the subsequent month. For instance, a data entry (e.g., weapons score, AFT score) recorded on 03 August 2026 will be applied toward the Soldier's promotion points for the 01 October 2026 COS. Army-level promotion decisions (COS and By-Name List selections) are made based on validated requirements and inventory data available at 0200 hours Eastern Standard Time on the second calendar day of each month. The Army then generates a Military Occupational Specialty (MOS)-specific Order of Merit List, ranking all integrated Soldiers from highest to lowest promotion score, to support Army-level promotion determinations. 3. **Roster Audit History (RAH)** – HR Professionals can access RAH within IPPS-A. The RAH provides a detailed, date-by-date breakdown of a Soldier's promotion points. Each date entry further divides the points by category, such as AFT, weapons, awards, and more. This tool enables an accurate response to Soldier inquiries. 4. **Soldier Referral Program (SRP) Extension** – The program is extended for 12 months effective 17 March 2026. Detailed guidance can be found within MILPER Message 26-201 – Click [HERE](#).
5. **Promotion Board Timelines** - Promotion boards are to be conducted between the 10th and 26th calendar day of the board month. Promotion boards held outside the dates listed above will be considered invalid. HRC Junior Enlisted Promotions will HQDA FLAG all Soldiers appearing before that promotion board. The unit will be contacted for submission of an exception to policy; if applicable - [Reference 1A](#), paragraph 3-9.
6. **Invalid Promotion Boards** - Promotion boards conducted with a First Sergeant or Master Sergeant (E8 or below) as the board president are invalid. HRC Junior Enlisted

Promotions will HQDA FLAG all Soldiers appearing before that promotion board. The unit will be contacted for submission of an exception to policy; if applicable – [Reference 1A](#), paragraph 3-10.

9. **ARC / ASC Difference Within IPPS-A** - Backdated promotion requests are submitted under Administrative Systems Correction (**ASC**) within IPPS-A. Submitting an Administrative Records Correction (**ARC**) for this purpose is the incorrect path, as **ARC** actions are non-pay-impacting and do not generate promotion orders. All backdated promotion requests must be submitted as an **ASC** using promotion PAR code **EXP** ([Reference 1B](#), Process 18-3).

10. **Integrations No Later Than 26th Day Of The Month** – Upon receiving the monthly promotion board proceedings ([Reference 1A](#), Figures 3-2 and 3-3), HR Professionals must ensure all integrations are completed no later than the 26th day of the month. To ensure integrations have successfully processed in IPPS-A, the follow-up validation steps should be done by confirming the Soldier's status using IPPS-A path(s):
